In pursuance of the decision of the High Power Committee in its meeting held on 20.02.06 and 23.3.06 copy communicated vide Govt. letter No. 9437/SME, Dt. 26.4.06 and Memo No. 18497/SME, dt. 16.9.06 and a per the guidelines issued by the Govt. in the Department of School and Mass Education, Orissa, Bhubaneswar vide Resolution No. 30720/SME, Dt. 23.9.96, No Objection certificate is granted in favour of Unique Public School, Nabarangpur, to open an un-aided Primary School upto class- VII for the purpose of obtaining affiliation from the ICSE/CBSE subject to the following terms and conditions.

1. The "No Objection Certificate" now issued shall be subject to the terms and conditions as prescribed in the G.O. No. 30720/SME, Dt. 23.9.96.
2. Medium of instruction in the School shall be English but Oriya shall be taught as a subject shall to all Pupil in the institution compulsory.
3. The School shall be open for inspection by the Inspection team.
4. No financial assistance and grant-in-aid (both recurring and Non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and Non-teaching staffs appointed by the Managing Committee.
5. The M.C. of School will not shift the present location of the school without prior approval of Director, Elementary Education, Orissa.
6. The High Power Committee shall review the N.O.C. granted to the institution concerned and shall withdraw the same if the terms and conditions contained in the GO No. 30720/SME, Dt. 23.9.96 is violated at any time.
7. The Managing Committee shall be constituted in accordance with the Section-7 of the Orissa, Education Act. 1969.

In pursuance of the decision of the High Power Committee in its meeting held on copy communicated vide Govt. letter No.22918/SME dtd.26.11.08 and as per the guideline issued by the Government in the Department of School & Mass Education, Orissa, Bhubaneswar vide Resolution No 30720/SME, dtd.23.9.1996. No objection certificate is granted in favour of Unique Public School, Nawarangpur, for a period three years to open an un-aided Secondary School upto Class-X for the purpose of obtaining affiliation from the CBSE/ICSE subject to the following terms and conditions.

1. The "No Objection Certificate" now issued shall be subject to the terms and condition as prescribed in the G.O No.30720-SME, dtd.29.9.1996.
2. The Land is to be recorded in the name of institution and copy of the record of the rights to be furnished by the authority of the institutions within one year from the date of issue of the order.
3. Own building of the school should be completed as per the norms on its own land with in one year.
4. Medium of instruction in the School shall be English but Oriya shall be taught as a subject to all pupils in the institution compulsory.
5. The school shall be open for inspection by the Inspection team.
6. No financial assistance and grant-in-aid (both recurring and Non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and Non-teaching staff appointed by the managing committee.
7. The M.C of School will not shift the present location of the school without prior approval of Director, Secondary Education, Orissa.
8. The untrained teachers will have to acquired training qualification within three years.
9. The High Power committee shall review the N-O C granted to the institution concerned in the next HPC after elapse of one year and shall withdraw the same if the terms and conditions contained in the G.O. No-30720/SME, dtd.23.9.96 is violated at any time.
10. The Managing Committee shall be constituted shall be constituted in accordance with the section-7 of the Orissa, Education Act-1969.
