Aims and objects / objectives of the Society:-

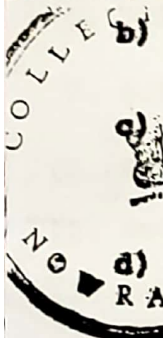
The Aims and Objectives of the society shall be to:-

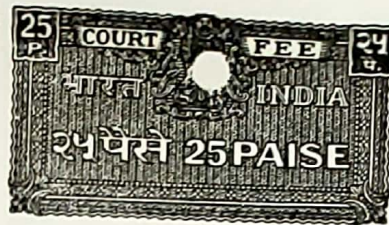

RULES AND REGULATIONS OF "UNIQUE CENTER FOR LEARNING"
NABARANGPUR, BLOCK/DISTRICT : NABARANGPUR, (ORISSA).

- 1) **NAME OF THE ORGANISATION:** The society shall be known as 'UNIQUE CENTER FOR LEARNING'.
- 2) **LOCATION OF REGISTERED OFFICE:** The shall be established at Sri Uma Reddy's Apartment ,1st Floor, Soura Street, Nabarangpur.
- 3) **AREA OF OPERATION:** The society shall be for the time being covers only for Nabarangpur Town and thereafter it shall cover Nabarangpur District or abroad.
- 4) **AIMS AND OBJECTIVES OF THE SOCIETY:**
 - A) The Aims and objectives of the society shall be to-
 - a) To fostal the spirit of solidarity and brotherhood among the members.
 - b) Encourage youths for effective participation in greater tasks of national reconstruction.
 - c) To impart vocational training to the needy people especially woman mass, which will help the trained generating additional income for their family.
 - d) To establish tailoring, wool knitting, weaving and other cottage Industrial Institutions for the women folk to impart training to them so that they can earn their livelyhood.
 - e) To start educational programmes such as professional education Adult Education, Literacy programmes and vocational training.
 - f) To establish Schools/Colleges/Study centres in the area of its operation. A School shall be established (English Medium) at the Headquarter Office of the society i.e. at Sri Uma Reddy's Apartme Ist Floor, Soura Street, Nabarangpur.

 - i) To accept donations from the funding agencies for various developmental programmes in the area of its operation.

5) MEMBERSHIP AND SUBSCRIPTION: The membership of the society shall be open to all bonafide residents of the Nabarangpur town as well as intrested outsiders in the age group of 18 - 40 irrespective of caste , creed, and religion. Any person who is intrested in the act-ivities of the society and whose age is above the limit can be an associate member.

- ii) Any person desirous to be an ordinary member subscribe to the Secretary and shall pay a monthly subscription of Rs10/- (Tenonly)
- iii) The Secretary may or may not accept the membership and also after the approval of the Executive Committee. (Body).

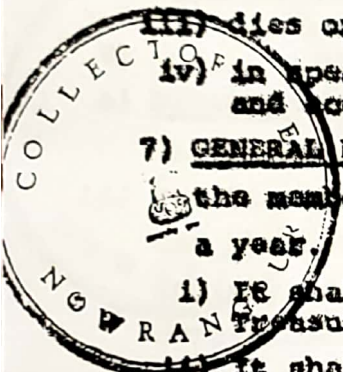
6) TERMINATION OF MEMBERSHIP : The membership of the society shall be liable to termination if any member:-

- i) of his/her own accord tenders resignation,
- ii) fails to pay the subscription consecutively for three months/years as indicated in the articles.
- iii) dies or leaves the station permanently.
- iv) in speeches and activities harms the society and it is approved and accepted in the General Body meeting.

7) GENERAL BODY AND ITS FUNCTIONS: The General Body shall consist of all the members as defined in By-Law and it shall meet atleast twice in a year.

- i) It shall adopt the annual report of the General Secretary cum - Treasurer regarding the activities of the society.
 - ii) It shall ~~adopt the amount~~ finally approve the duly audited expenditures of previous year the revised budget estimate of current year if any and the budget estimate of the coming year for the maintainance of the school etc.
 - iii) It shall elect the office bearers and other members of the Executive Committee (Body) their terms of office shall be for two years.
 - iv) A quorum shall consist of the attendance of one third/one fourth of the total member of the society or 10 members.
 - v) A majority vote by members present shall decide the election of office bearers and other items on which voting is necessary.
- With the approval of the Director the General Secretary shall convene the meeting of the General Body. The members should give clear 15 days notice. In case want of quorum the adjourned meeting shall be from its quorum.

8) EXECUTIVE BODY & ITS FUNCTIONS: There shall be an Executive Committee (Body) of 7 members consisting of Director, General Secretary cum - Treasurer, Joint Director, Joint Secretary and three ordinary member. All elected for two years.

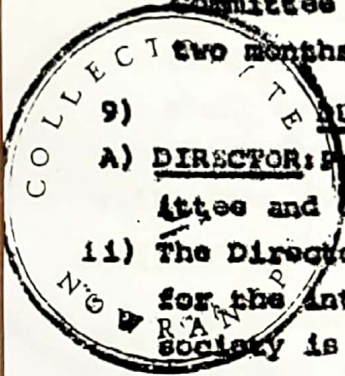

- i) The Executive Body shall ordinarily meet once in every fortnight or month, to deal with the day-to-day affairs of the society and transact there business as per rules.
- ii) The Executive Body shall approve the audited receipts and expenditure statement of the current year. It shall also prepare budget estimate for the next year and after approval of the General Body shall move to the Government and other Institution for financial aid and other possible helps.
- iii) The Executive Committee shall have the power to form a sub-committee as and when necessary.
- iv) The Executive Committee shall make a quorum to the attendance of one-third of the total members of the committee of 10 members.
- v) The society shall have to intimate any change in the Executive Committee to the Addl. Registrar of the Societies Nabarangpur within two months of such change.



9) DUTIES OF THE OFFICE BEARERS:

A) DIRECTOR: Preside over and conduct the meeting of the Executive Committee and General Body meeting per Parliamentary Procedure.

i) The Director shall be liable for penal of action at his personal capacity for the delinquency noticed by the registering authority and the society is not liable for dissolution at any time and the registration certificate can be cancelled without prior notice or assigning any reason thereto.

ii) To maintain the study centres and other vocational training centres and School as principal officer of the center on behalf of the society

iii) To follow up the activities of the society for its successful implementation.

iv) He shall have the power to appoint/recruit/employ, discipline, terminate or dismiss any worker/employee for the purpose of the society in consultation with the management.

v) He shall be responsible for approval of all day to day expenses and monetary transactions. He shall be responsible for proper management and utilisation of all funds of the society.

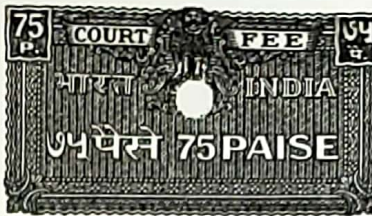
vi) He shall control, administer and supervise all the staff employed under the society. He is authorised to take disciplinary action against any employee if necessary after obtaining the consent of the

B) JOINT DIRECTOR: He/She shall exercise some powers which were given by the Director time to time and in the absence of Director he/she shall exercise the powers of Director for time being.

C) GENERAL SECRETARY CUM TREASURER: He/She shall call all meetings of the society and Board of Management/Executive Committee in consultation with the Director.

ii) He/She shall record all minutes and resolution, present them for the approval of the Director and arrange for their circulation.

iii) He/She shall be the official correspondant of the society.

iv) He/She shall arrange for safe keeping of all records and documents including accounts.

v) He/She shall sue or be sued on behalf of the society.

vi) The General Secretary shall have supervisor powers over all financial aspects of the work undertaken by the society. He/She shall be responsible for the preparation and presentation of all the Budget and Financial statements etc.

vii) He/She shall collect the dues of the society and maintain the records

viii) He/She shall have an imprested cash of ₹100/- (Rupees one Hundred only)

and deposit the excess in the local state bank of India in a joint accounts opened on behalf of the society in the name of Director and General Secretary cum Treasurer with joint drawing power.

D) JOINT SECRETARY: Assist the Secretary.

iii) In the absence of the Secretary, perform all the duties of the Secretary except the monetary transaction.

ADVISORY COMMITTEE: The well wishers of the society who are intrested in social work three active members of the society. The committee shall help, guide and advice whenever necessary and when the Executive Committee desires the help of the Advisory Committee. The Advisory Committee shall not interfere or involve with the affairs of the Society without requisition of the Executive Committee members.

11) MOTTO & SLOGANS:

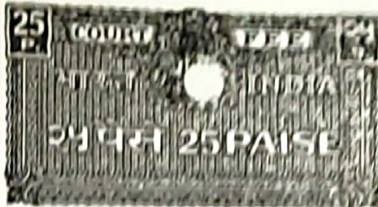
a) The society shall have its own Motto and Slogan which should not have any political significance or bearing whatsoever.

13) FINANCE : The Society shall be financed out of :-

- a) Admission fee and monthly/yearly subscription, Contribution and Donations.
- b) From the sale proceeds, if any of group projects,
- c) Financial aid from the Government and bonafied Voluntary Agencies.

ii) A Bank account should be opened in the name of the Society with joint drawing power of Director and General Secretary cum Treasurer in State Bank or any Nationalised Bank of India in Nabarangpur.

iii) The Financial Year of the society shall be from 1st April to 31st March as per the Government Procedure.

14) AUDIT : The Accounts shall be audited by a Government Auditor or by a qualified auditor annually. The General Secretary cum Treasurer of the Society must have to attend the annual audit with the Director.

15) DISSOLUTION : If two-third of the total members of the society decide for the dissolution of the society, it shall be dissolved forthwith at the time then agreed to its assets shall be handed over to a registered society with similar objects or Government after clearing up its debts and liabilities under intimations to the registering authority.

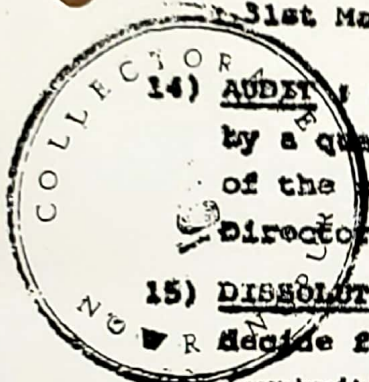
16) AMENDMENT OF BYE-LAW :

a) The BYE-LAW of the Society or part thereof can be amended by a majority vote of 2/3 members of the General Body. The notice for such proposals has to be submitted in writing to the General Secretary at least 10 days before the date of general body meeting. The proposal has to bear the name and signature of the proposer and three supporters, all of whom must be the members of the General Body.

b) Copy of the amendment when accepted by the General Body shall forthwith be submitted to the Registering Authority for information with one month of its alternation duly attested by three executive members.
